PLANNING FOR OUR ASSOCIATION'S FUTURE

The Texas ALP Planning Committee is comprised of various members throughout our state association. Pursuant to the Texas ALP Policies & Procedures Manual, this committee shall be comprised of four members to include an experienced member; an officer of Texas ALP who has served at least one year as an officer; a new member; and a member under the age of 35. Julie Abernathy, PP, PLS, is serving as Chair for this year. Joining Julie are Emily Walterscheid (experienced member); Jeri Locknane (Texas ALP officer); Brittni Hall (member under the age of 35); and Krystin Miller (new member).

During the Texas ALP Executive Committee Retreat held in mid-May, the officers reviewed the existing plan. This committee received their input and appreciate their guidance toward the future of Texas ALP.

A revised Strategic Plan (or otherwise called a Long-Range Plan) starts with a vision.

But it requires first developing a shared vision for the future, creating a mission that points the association toward the fulfillment of that vision, setting forth some practical achievable goals toward fulfilling its mission, planning to reach those goals, putting the plan into action, dedicating our energies to these plans over our personal comfort, and sticking with it for the long haul regardless of immediate results.

It is more about looking at generational change, the hope for a decade from now, two decades, and even three decades. BUT – our Association must plan AT LEAST the next 3-5 years.

If the goal is to relive the past, we will not be present in the future. We cannot go forward by the same gate we came in. We do not need to throw out who we were and are. We simply need to ask honestly, "How does this remind us that each of us is an integral part of our association's commitment to helping its members be the best legal professionals possible?"—and that means having an Association to guide, educate, and nurture us to achieve that purpose.

The future of the Association is not to replace itself nor to forget its rich heritage and where it came from, but to grow into what it will be in that time. The Association cannot do that by aiming towards what it was. It must look to the future. It starts with a vision...a dream.

The Planning Committee developed a preliminary survey that was sent to all the members. To be truthful, it was disappointing to see the lack of responses. Does that mean our members don't care? Does it mean our members do not take time to read and respond to surveys? If that is true, then the Planning Committee needs to look at other ways to gather information to form and implement our new long-range plan.

The Planning Committee will now focus on other priorities, as mentioned above.

What is our mission?

Texas ALP promotes a high standard of competence for legal support professionals.

Should it change from the existing mission? If so, please let our Planning Committee know your thoughts.

What is Texas ALP's vision? The existing Plan calls them "core values."

Respect, Loyalty, Courtesy, Cooperation, Competence, Integrity, Professionalism

Should it change from the existing core values?

And what are our goals, other than the obvious?

- > Commit to Code of Ethics
- > Provide opportunities for legal education
- > Provide opportunities for networking
- > Support certification
- > Provide opportunities for professional development

Should all change? Only some, or throw it all out and start fresh?

An example we heard during the Open Forum at the Annual Conference this past April in Waco was to retain existing members, recruit new members, certify our members (and future members through NALS), and continue with legal education programs, both in-person and virtual by way of Zoom events or webinars.

The first survey asked for input on four core "values" of Texas ALP. (1) Membership; (2) Education; (3) Certification; and (4) Marketing, with a final question on what are "Your Big Ideas." The survey consisted of 14 questions or requests for response/input. One very glaring item kept being repeated: social media. Our Association needs to participate in a more social media presence. Not just Facebook, but also Instagram, TikTok, X (formerly Twitter), and LinkedIn. Potential members are young and tech savvy. It is important that our chapters stay relevant by consistently posting on social media.

Any new plan will require input and commitment by ALL our members. It is not a committee of five who will implement the plan once it is presented to the Executive Committee for approval. Nor is it the five members of the Executive Committee who are the only members who are responsible for implementing the goals and objectives that our Association desires. As the saying goes, It Takes a Village.





Remembering

Jani "Beth" Blackerby Walker, PLS, CLA

"How Do You Wish to be Remembered?" This reminded me of a special person in my life who left life on April 15 this year and probably joked that it was a good time as she did not have to file taxes for the year.



That person was Jani "Beth" Blackerby Walker. She was the "preacher's daughter" who had a thirst for knowledge and during her early years attended 13 different schools, graduating at the top of her class from Snyder, Oklahoma, and then attended 5 different colleges. She met the love of her life, Jefferson Walker, in Oklahoma in 1956 and they settled in Clarendon in 1964.

In Clarendon she worked for the law firm of Lowe, Courtney and Shelton as a legal secretary, bookkeeper, legal assistant, office manager, and "jack of all trades" until she retired. She joined NALS in 1972 and became deeply involved in the Texas Association of Legal

Secretaries (now TALP) and NALS, serving in various positions and offices in both organizations. Beth was TALS Legal Secretary of the Year in 1976 and was installed as the 31st President of TALP in 1985.

She had not yet done everything she could for the association. Her history in her career field with the Tri-level Association continued. During the 1986-87 year Beth attended a NALS Leadership workshop on behalf of TALS. In 1987-88 she attended another leadership workshop with Donna Dendy and Judith Smith and the three became members of the 1988-89 leadership team. Programs were developed and presented for local chapter workshops. In 1992 NALS recognized the Texas leadership team and it became the NALS Leadership Team and won the nationally acclaimed Keystone Award.

Beth served our association well. As I look at her history, I see her in a leadership role (1986-96) with Donna Dendy and Judith Smith doing workshops nationwide, chairing or working on the PLS Certifying Board, helping develop the ALS exam for NALS and the Texas Specialty Examination-Civil Litigation and

Real Estate. She was instrumental in developing the PLS Education Institute, which later became the National Education Institute as an Instructor.

Many association members looked to her for guidance in working with difficult members and interpreting the never-ending array of policies, procedures, and bylaws of our association. Her explanations were always clear. Beth's leadership qualities stood out and she was urged to take a leadership role in the national association. She declined as she believed that the younger members should step up and be heard. She encouraged those members to seek office and work within the association.

Beth and Judith Smith became close friends and often debated verses of the Bible after long days of TALP meetings. It was important to them. Her faith was strong and she radiated that faith in all her dealings with our association members. She believed strongly but accepted that others might not feel the same and respected that.

Beth made a profound impact on my life and many others – family, church friends, association friends, and clients of the law office where she "took care" of them. She was a cornerstone in the foundation of our association. She was a mentor, motivator, and an example of professionalism.

On April 15, God closed her eyes and told her to rest. She had done enough. We don't like to lose our friends, especially those who have made a profound impact on our lives. Donna Dendy, Judith Smith, and I visited Beth and Jeff in Amarillo before she left us. We're glad we did.

How would Beth want to be remembered? For her many friendships in the Clarendon and Amarillo legal community. For the church members who looked to her to take care of the youth choir. For her kindness in always speaking to new members of our association, offering help, and getting to know them. I think it would be about love of family, her friendship, her knowledge, her love of God, her church, and this association. She is truly missed by those who knew her.

My thoughts on "One Member, One Vote (those in attendance)"

Many of you know me, but some don't. My name is Emily Folsom, I am from Waco, I joined Waco LPA, TALP, and NALS in 2018. Over the past couple of years, I have been guided to join the leadership team in Waco and slowly evolving into TALP. I am a younger member to this organization, constantly being asked how to get the younger members involved like me. Well, one thing I know could possibly do that is allowing one member one vote (to those in attendance).

During the 2024 Fall Conference Board Meeting, the topic of doing one member one vote (for those members in attendance) was brought up for discussion. Upon looking into this more, I discovered both pros and cons to allowing each member (in attendance) a vote. I thought I would share my findings and thoughts with you.

Right now, the association votes via Director of each chapter. I asked "seasoned" members who have been with the association to share their thoughts and knowledge with me. The majority of them said that the concern they have is that some of the bigger chapters could out vote all other chapters. They also said that when they had over a hundred members attending these meetings, it was tedious to count all the votes. I don't disagree, it was stressful just counting the 10 at this year's meeting. However, looking at the numbers from the 2024 Annual Conference and the 2024 Fall Conference, our numbers are nowhere near the hundreds. The total number for the 2024 Annual Conference was 32 members. I just want to remind you that we currently have 204 active members. The total numbers for the 2024 Fall Conference (that was held virtually) was 33 members.

The following numbers are for each chapter and the number of members they had attend the 2024 Annual Conference and the 2024 Fall Conference.

As we all know, these are very low numbers for the amount of good standing, active members that we have. I personally would like to see all 204 members attend our conferences. Looking at the numbers and seeing who was at the conference, it seems that the majority of people who attended were either officers or chairs; people who didn't have a vote but were there because they had to be. I say had and not want, because if they did not need to fill a chair position, how many would have still attended?

The constant struggle is how to get more members active in the association. The question always is, "how to get younger members to join or become more involved." I personally think that allowing one member one vote (to those in attendance) to go into effect would do a number of positive things for the association:

- 1. It will force the younger/newer members to really get involved in the changes. They will have to attend to really see their vote make a difference.
- 2. It will allow the younger/newer members to read and understand (learn) the reasons things are done.
- 3. It will allow the younger/newer members to feel like they are truly making a difference in the association, that is not run by the more seasoned members.
- 4. It will allow for more discussion.
- 5. It will allow members to teach and network either their memories or new ideas.
- 6. It allows our members-at-large an opportunity to have a voice.
- 7. More members will attend our meetings.
- 8. More money for the hosting chapters.

The things that I can see being a struggle with the one member one vote (those in attendance) are that:

- 1. Members (new and seasoned) will not read or care about the information that is being put out.
- 2. Bigger chapters that have more members getting to be able to determine all the changes by getting more of their members to vote.
- 3. People can be "told" how to vote and won't really do it for themselves.
- 4. People could want to have a bid by proxy which can cause more issues.
- 5. Counting all of the votes.
- 6. People really understanding what they are voting for.

This is not about the new/younger members taking over. It is about the younger members and the seasoned members working together to make this organization last. The seasoned members can teach us younger members the traditions and reasoning behind the organization. The new members can bring their fresh ideas and thoughts to help keep the traditions alive and make new ones.

There is not an easy solution to this, but I feel that we should not overlook the opportunity to make a change. The association needs to grow and change continuously, we cannot just stay in our ways, because that is how it has always been done. This was even discussed in the professional development about how far the association has come and how much further we have to go.

This is the time for ALL members to learn, grow, and be part of a change for the Association.







It's not bragging, well maybe just a little bit


